### **Proposed Internal Corporate Reorganization for IHS Markit in Japan**

IHS Markit is pleased to announce that in connection with the ongoing integration plan related to the merger of IHS and Markit, IHS Markit will be carrying out an internal group reorganization with respect to its subsidiaries in Japan to be able to provide more efficient operations and services to our customers in Japan.

On 1 October 2018, IHS Markit Group Japan K.K. (IHSマークイットグループ日本株式会社) will merge into IHS Global KK (IHSグローバル株式会社) (address: 3-1-1 Kyobashi, Chuo-ku, Tokyo 104-0031, Japan) with IHS Global KK as the surviving entity of the merger, and IHS Global KK will convert from a KK (joint stock company) to a GK (limited liability company) on the same day and be renamed IHS Markit Japan GK (IHSマークイットジャパン合同会社).

IHS Markit remains committed to providing its customers in Japan with the highest level of service that they have come to expect from IHS Markit. The merger of our two subsidiaries will permit us to provide high quality operations and customer service in an efficient and streamlined manner, and provide a single organization in Japan from which to offer all IHS Markit products and services.

All agreements between either IHS Global KK (IHSグローバル株式会社) or IHS Markit Group Japan K.K. (IHSマークイットグループ日本株式会社) and all customers and third parties will be automatically retained by IHS Markit Japan GK (IHSマークイットジャパン合同会社) at the completion of the reorganization (i.e. the merger and the conversion to a GK) and will continue on their existing terms in all respects, other than changing relevant references to our legacy subsidiary names to refer to IHS Markit Japan GK (IHSマークイットジャパン合同会社) as appropriate. From 1 October 2018, invoices will be issued by, and fees thereunder will be payable to, IHS Markit Japan GK. To facilitate these payments, can we please ask that you add "**IHS Markit Japan GK (IHSマークイットジャパン合同会社)**" as an additional vendor on your systems to process payments. If your agreement has been entered into with another IHS Markit subsidiary or affiliate, there will be no changes to that agreement in any way.

We will provide additional communications at the time of the completion of the reorganization with further details about IHS Markit Japan GK (IHSマークイットジャパン合同会社) that will assist you in updating your systems.
