

IHS Markit Terms of Use

The following Terms of Use apply to the Service provided by IHS Markit to You. By accessing the Service You acknowledge and irrevocably represent that You have read and understood, and agree to be bound by the Terms of Use. If You do not agree with these terms and conditions, do not access or use the Service.

1. Definitions

“Terms of Use” means these terms and conditions.

“Trial Period” shall take effect upon delivery of the Service, is **free-of-charge**, and shall automatically expire **twenty-one (21) days thereafter with no obligation to subscribe post the Trial Period**. Upon any termination or expiration of the Trial Period, You shall cease using any portion of the Service and purge all data or information contained in the Service from Your electronic or other systems.

“Service” means all information provided by IHS Markit and/or its third-party providers to You which may be accessed electronically or delivered/received in physical format. Service may include any web tools, search engines, or software provided by IHS Markit that can be used by You when accessing the Service which You agree to use only for purpose of accessing the Service and are subject to the restrictions as set forth herein. IHS Markit reserves the right to replace, discontinue or make any change to the Service.

“You(r)” means you as the individual user, and the entity that you are authorized to represent, contract and use the Service described herein on behalf of.

2. Limited License

Subject to and in consideration of Your compliance with these Terms of Use, IHS Markit grants You a personal, **free-of-charge**, non-exclusive, non-transferable, revocable license solely for internal trial and evaluation of the Service. Any log-ins provided are personal and may not be shared. You may not assign any of Your rights or delegate any of Your obligations hereunder and any attempted assignment shall be null and void. These Terms of Use sets forth the entire agreement between us and supersedes any and all prior proposals, agreements or communications, written or oral, of the parties with respect to the subject matter hereof.

3. Ownership

You shall not reverse decompile, disassemble or otherwise reverse engineer any Service in whole or in part.
