

## IHS Markit Chemical Pulse License Terms

The following License Terms apply to the Service provided by IHS Markit to You. By accessing the Service, You acknowledge and irrevocably represent that You have read and understood, and agree to be bound by the License Terms. If You do not agree with these License Terms, do not access or use the Service.

### 1. Definitions

**"Internal Use"** means use by You in relation to Your internal operations which use shall not include: (a) the use of all or any part of Services including any Report licensed hereunder to provide any Service to any third party; or (b) giving or allowing of access to, or to otherwise disseminating, all or any part of such Services in any manner whatsoever to any third party (including Your Affiliates unless otherwise expressly permitted).

**"License Terms"** means these terms and conditions.

**"You(r)"** means you as the individual user, and the entity that you represent.

### 2. Limited License

Subject to and in consideration of Your compliance with the Terms of Use, IHS Markit hereby grants You a personal, non-exclusive, non-transferable, non-sublicensable, and revocable license to the Service solely for Internal Use. Any logins provided are personal and may not be shared. You may not assign any of Your rights or delegate any of Your obligations hereunder and any attempted assignment shall be null and void. These License Terms set forth the entire agreement between us and supersede any and all prior proposals, agreements or communications, written or oral, of the parties with respect to the subject matter hereof.

### 3. Ownership

You shall not reverse decompile, disassemble or otherwise reverse engineer any Service in whole or in part.
