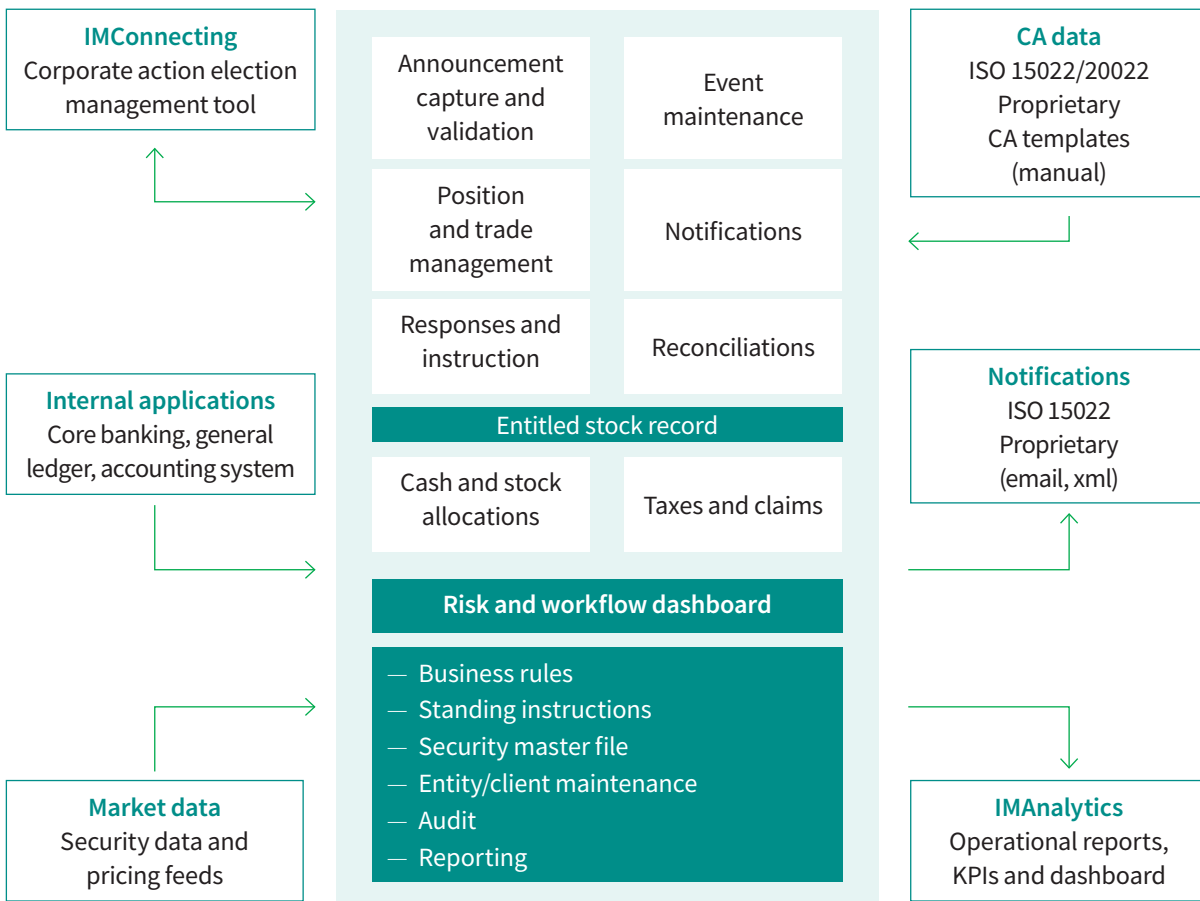
## Counterparty deadlines, broker protection & liability management
