The index rules are transparent and the index is independently calculated and administered by IHS Markit.

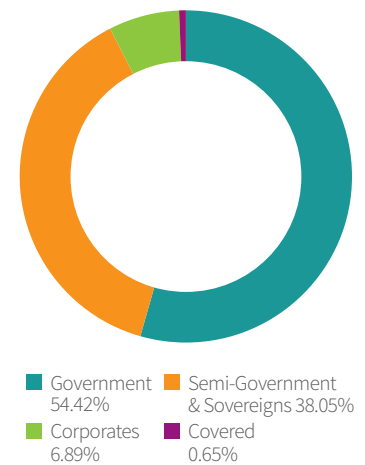

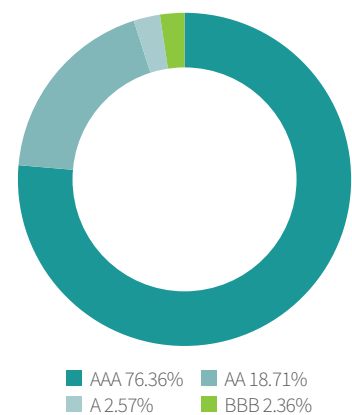
Sector Breakdown
