Leveraging our expert knowledge of regional and exchange requirements, our solution is designed to bring portfolio and pricing transparency to market participants, supporting various methodologies across multiple asset classes.

Portfolio composition data is adjusted not only based on changes in underlying benchmarks, but also using independent corporate action and dividend data, and validated through a calculation engine, with a comprehensive system of quality controls. PCFs are timely constructed, including underlying constituent data and indicative NAV calculations, and distributed through our established connections to market makers, authorized participants, exchanges and data vendors.

In addition to PCF services, our iNAV+ offering calculates live prices for funds and ETFs globally across all asset classes. We price baskets from the bottom-up every second by combining our market-leading composition data and bond evaluation service with real-time market data and fair value adjustment models.
