The iBoxx USD Liquid Leveraged Loan Index is a subset of the benchmark Markit iBoxx USD Leveraged Loan Index (USD LLI), which represents the main sections of the USD leveraged loan market. Liquid indices are designed to track the broader market with a smaller subset of index constituents, providing a suitable basis for derivatives and Exchange Traded Funds (ETFs). The procedure utilizes daily liquidity scores from the Markit Loan Pricing Service, which is a broader measure of liquidity, summarizing the performance of each loan across several liquidity metrics, such as number of quotes, or bid-offer sizes.

The indices are part of the global iBoxx index families, fueled by multisource pricing. iBoxx indices offer representative and objective benchmarks for assessing the performance of bond markets and investments.

Documentation on our rules-based methodology for constituent selection, monthly rebalancing and daily total return calculations is publicly available.
