iBoxx[®] Global Green Bonds Select Index

iBoxx[®] Global Green Bonds Select Index is designed to reflect the performance of green bonds as classified by Climate Bonds Initiative (“CBI”). The index includes investment grade and high yield government, sub-sovereign and corporate debt denominated in EUR, USD, GBP and CAD, whilst upholding minimum standards of investability and liquidity. The index is part of a range of available iBoxx sustainable indices.

Green Bonds as classified by CBI satisfy the criteria laid out in CBI’s proprietary green taxonomy, as well as CBI’s standards on transparency and bond ‘Use of Proceeds’. CBI’s green taxonomy ensures that eligible bonds are aligned with the goals defined in the COP21 Paris Agreement.¹

The index minimum amount outstanding and time to maturity rules are lowered as compared to other iBoxx broad indices in respective currencies to better reflect the underlying market. Rated bonds across investment grade and high yield are eligible.

The index is rebalanced monthly on the last business day of the month and is weighted by market value. Transparent, independent, objective, and multi-dimensional coverage across all asset classes.

Transparency

Documentation on our rules-based methodology for constituent selection, monthly rebalancing and daily total return calculations is publicly available.

Independence

iBoxx[®] products utilize independent multi-source pricing and reference data subject to rigorous quality testing, with a fully documented price challenge process in place. We are committed to administering all financial benchmarks in compliance with IOSCO benchmark principles and is an authorised benchmark administrator under the European Benchmark Regulation (BMR).

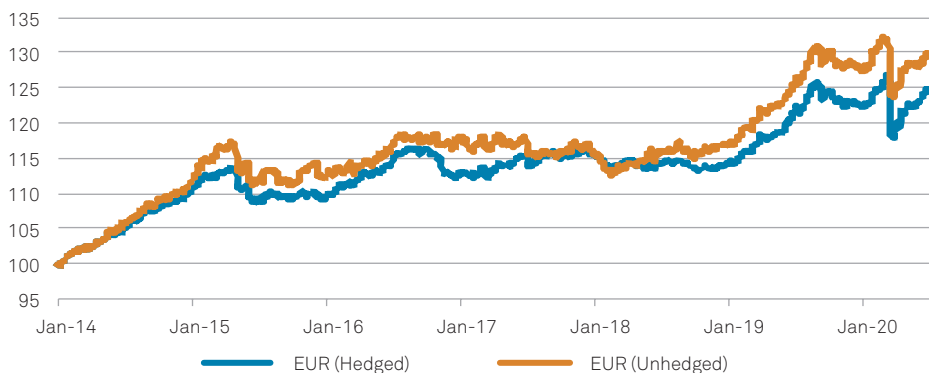

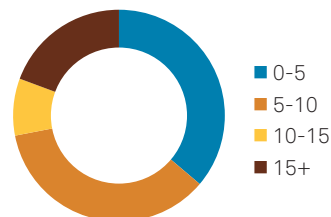

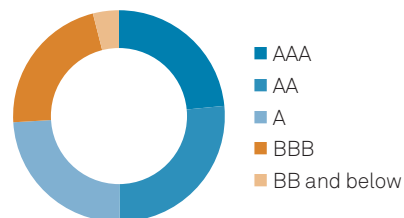

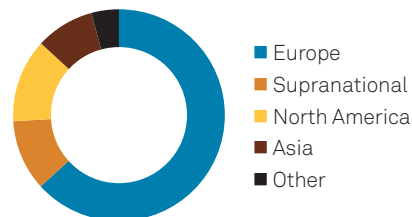
Maturity distribution (as of 30 June 2020)



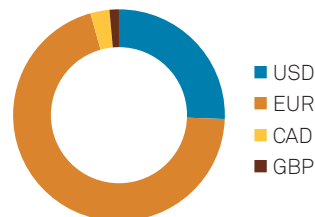
Credit rating distribution (as of 30 June 2020)
