Monthly US IPO Brief

January Recap

- January opened the year with impressive IPO figures relative to the prior-year period, boasting \$2.3B in proceeds over 8 deals, representing a substantial increase from the 1 IPO that raised \$322M in January 2019. The months largest deal came from the Industrials sector, as Reynolds Consumer Products, Inc. outshined the new issuance market by a wide margin, generating \$1.2B in proceeds. Additionally, Black Diamond Therapeutics, Inc. showed impressive pricing performance, increasing 107.8% on its first day of trading after pricing above its filing range. The Healthcare sector saw the most deals come to market in January, debuting 4 deals for proceeds \$810.8M.
- Capital markets indices in January 2020 exhibited mixed performance led by the U.S. Based 25 Index, which posted returns of 25.33% with a 1.09% average daily increase. The International 25 Index outperformed the U.S. Based 25 Index for the majority of January before it plummeted on the back of a 4% decrease in a single day. The greater stock market saw lackluster performance with the S&P 500 finishing the month in the red at -0.16% and never breaking the 3% threshold. Elsewhere RAPT Therapeutics, Inc. has shown the largest increase since its offering in the trailing 12 months, leaping 269.1%. Alternatively, Sundial Growers Inc. has shown a 90.8% decrease since its debut in early August.
- -The current 6-month IPO backlog stands at 20 issuers seeking to generate \$1.98B in proceeds, a substantial increase when compared to the same period in the prior year where only 5 deals were expected for \$1B in total proceeds. Looking at individual sectors, Tech/Telecom, Healthcare, and Consumer Services all have 5 deals in the backlog with Tech/Telecom leading in terms of proceeds with \$779.0M.

IPO Brief Notes

The IPO Brief tracks offering statistics and aftermarket performance of IPOs satisfying the following criteria:

- Must be publicly traded on a US-based stock exchange
- Must raise initial proceeds greater than or equal to \$20M

IPOs that are excluded from the report include:

- Closed End Funds (CEF)
- Special Purpose Acquisition Companies (SPAC)
- Private Placements / 144A

- Private Investments in Public Equity (PIPE)
- Equity Unit Offerings

Other Notes:

Offer vs. File range statistics are based on the most recent amended file range. Proceeds do not include any exercised overallotment: "Usabased IPOs" are Us-domiciled and US-listed. "International IPOs" are non-US domiciled and US-listed. Proceeds by bookrunner are apportioned proceeds. The backlog tracks deals filed or ammended within a trailing 180 -day period.

† IPO Indexing Methodology

The Iproo IPO indices track trailing one-month price performance of the 25 most-recent US-domiciled IPOs, and the 25 most-recent non-US domiciled ("International") IPOs (members of both constituents must be listed on US-based exchange). Exclusions from the constituent groups are detailed above.

Trailing price performance is calculated by taking an un-weighted average of daily percent changes across a given historical date's 25 US and 25 International most-recent IPOs. The 25 US and 25 International constituents may not remain consistent over the full 30-day period, and can adjust daily to accommodate new IPO or release old IPOs falling out of the relevant grouping. The unweighted average daily percent change is then applied to a base value of 100 given to each index, including the benchmark S&P 500. The basic indexing formula is given below:


