Building on many years' research, the study:

- a. updates and identifies inland barge fleets by operator;
- b. provides fleet demographics;
- c. shows recent new barge construction and depicts historic barge building trends; and
- d. shows barge freight rate information.

We include detailed data on both the dry bulk and liquid barge fleets and update the continuing record of mergers and consolidation. This is the only analysis of the inland water transport industry that is both comprehensive and timely. Results are based on a carrier survey, and the report is prepared by IHS Markit. The American Waterways Operators, Inc. has endorsed this study.

IHS Markit is releasing the seventeenth annual *Barge Commodity Profile* report. Like the *Barge Fleet Profile* report, this report has proven to be an invaluable resource for any organization involved in inland waterways operations. This analytic report of historical information incorporates the domestic internal waterborne commerce data of the Army Corps of Engineers by type of barge movement.
