Securities Finance Beneficial owner service

Creating transparency for beneficial owner's lending programmes

Our service offers beneficial owners a web-based application for analysing and reporting on lending programmes.

Customers can gain insight into how their programmes are performing by measuring performance against specified benchmarks and identify funds, counterparts and instruments that contribute to their securities finance revenue.

The flexibility of the application allows reports to be customised to specific requirements, and customers have access to a broad range of reporting results, including multi-agent consolidation of inventory, transactions and collateral. Reports can be scheduled to run daily, monthly, quarterly, semi-annually and annually.

Extensive coverage

Leverages a dataset covering more than \$20trn global securities, with a historical database dating back to 2002, to support investment decisions.

Performance benchmarking

Benchmark portfolios, including securities lending rates and volumes, against peers and the market to help identify new revenue opportunities.

Risk management

Aggregated exposure report that collectively analyses risk exposure across variables such as counterparties, asset classes and instruments.

Customisable

Customise peer groups based on lending program styles and tailor data views by filtering trade types and lending characteristics.

Efficiency

Combined views of performance and risk at the individual agent or programme level for quick assessment.

Bespoke reporting

Top performing securities and fund analysis including stress testing based on historical events. Consolidated reporting available for multi-agent performance and risk measurement.



Agent Lender returns vs weighted group




Top Earning securities
